### **Renewing Your Membership**

You no longer need to complete a form **if your details, address, telephone numbers and email are unchanged**. You simply need to confirm by email to the membership secretary, and pay your subscription by BACS, or by cheque or cash at one of the coffee mornings, or post to the membership secretary, whose name is on the forms.

**If your contact details have changed**, please complete the Membership Application and Changes form, and return by 1 August by post to the membership secretary, or bring them to the coffee morning at The View in July or August.

**If you do not wish to renew**, please email the membership secretary.

### **Associate Membership**

If you are already a member of another local u3a, you can join Seaford and pay a reduced annual subscription. However, you must complete the membership application form and give the name of your main u3a.

## **Gift Aid**

### **This applies to all new members or members re-joining after a break**

If your income is taxable, you may wish your membership fee to be treated as a gift aid donation. Please confirm this on your membership application which will enable this Charity to reclaim 25p of tax on every £1 that you pay on or after 6<sup>th</sup> April annually.

We ask that members notify the Treasurer if

- You wish to cancel your Declaration
- If you change your home address
- If you no longer pay Income Tax at the higher or additional rate and want to receive the additional tax relief due to you. You must include all your Gift Aid donations on your Self Assessment tax return or ask HM Revenue and Customs to adjust your tax code.
